<b>Manual Classified Counts (MCCs):</b> <i>Involves undertaking <u>accurate</u> traffic and/ or pedestrian count surveys on sections of road or road junctions using hand-held tally counters. Work is carried out from the roadside at a variety of locations, <u>usually outdoors</u>; <u>often work commences at 07:00</u> and typically would involve either a split shift of 2-3 hours AM and PM or 12 hour 07:00 - 19:00</i>	Yes / No
<b>Queue Length Surveys:</b> <i>Often conducted in conjunction with counts and require <u>accurate recording</u> of queue lengths at road junctions. Work is always outdoors.</i>	Yes / No
<b>Interview Surveys:</b> <i>Involves asking members of the public questions for a variety of purposes. Work is usually carried out on street, but could be at shopping centres, in car parks or doorstep surveys. Generally surveys are associated with transport/ travel patterns, but could be for broader market research purposes. Confident approach and ability to speak English to native standard is essential.</i>	Yes / No
<b>Parking Surveys:</b> <i>Usually involves undertaking parking 'beat' surveys in car parks or on street. Requires the <u>ability to walk a beat at specified intervals</u> throughout the day recording partial vehicle registrations; usually amounts to <u>approximately 8-10 miles</u> over the course of the day.</i>	Yes / No
<b>Registration Plate Surveys</b> <i>Involves recording registrations of moving vehicles, either on street or at car park accesses. <u>Good eyesight is essential</u> to be able to accurately record registrations at the required distance.</i>	Yes / No
<b>Journey Time Surveys:</b> <i>Involves driving a pre-determined route at specified time periods with video recording equipment or GPS equipment fitted in the vehicle. By definition, this type of work is only suitable for drivers, and requires the ability to drive at the 'average road speed' to provide representative results.</i>	Yes / No
<b>Video Count Surveys:</b> <i>Involves undertaking MCCs (as detailed above) on a TV from video recorded images. This work is <u>office-based</u> and usually involves 09:00-17:00 working day.</i>	Yes / No
